Norse Atlantic Airways receives Air Operators Certificate

The Norwegian Civil Aviation Authority has issued an air operator's certificate (AOC) to Norse Atlantic Airways. The new airline is on track to start transatlantic flights in spring 2022. This requires the operator to have personnel, assets and systems in place to ensure the safety of its employees and the general public. Norse plans to start commercial operation in spring 2022 and the first flights will depart from Oslo to selected cities in the U.S.

Aviation Capital Group commits to 60 Airbus family aircraft

Global full-service aircraft lessor Aviation Capital Group (ACG), wholly owned by Tokyo Century Corporation, has signed a Memorandum of Understanding (MoU) for 20 A220s and a firm contract for 40 A320neo Family aircraft, of which five are A321XLRs. With this order ACG is supporting the recently launched multi-million dollar ESG fund initiative by Airbus that will contribute towards investment into sustainable aviation development projects.

Ethiopian receives CEIV Pharma certification

Ethiopian Airlines announced that it has received IATA's Centre of Excellence for Independent Validators in Pharmaceutical Logistics (CEIV Pharma) certification as an airline and ground handler. The airline states that it is the first airline in Africa to do so. The IATA CEIV certification comes at an opportune time for Ethiopian Cargo and Logistics as they continue to play key global role in the transportation of life saving COVID-19 vaccines around the world and particularly in Africa.

Frontier Airlines recounts 2021

As a remarkable year of growth

These new partnerships, and the order for additional aircraft to satisfy Frontier's growing network needs, put the airline on the path to triple in size by 2029.

UPS signs purchase order for 19 Boeing 767 Freighters

UPS has signed an order for 19 Boeing 767 Freighters at a time of robust air cargo demand. “The Boeing 767 is the most versatile aircraft we operate,” said UPS US Operations President, Nando Cesarone. “Our plan to purchase 19 aircraft and take delivery between 2023 and 2025 aligns with the strategy and capital expenditure forecast shared during our June 2021 investor and analyst day. It also supports our sustainability efforts by making our fleet more efficient and improving reliability,” he said. The deal adds to a record-breaking year for Boeing freighter sales, including 80 firm orders for new wide-body freighters and more than 80 orders for Boeing Converted Freighters. In 2021 air cargo demand has surged due to an expansion of e-commerce and express cargo markets.

Eve and Republic Airways sign MoU for up to 200 eVTOL aircraft


Eve Air Mobility, an Embraer company, and Republic Airways Holdings have signed a Memorandum of Understanding and Letter of Intent to purchase up to 200 of Eve’s electric vertical take-off and landing aircraft (eVTOL) to explore additional opportunities within its subsidiaries, such as the LIFT Academy, that are focused on workforce development initiatives and the future of air travel. The strategic relationship will focus on developing a deployment network throughout the Central and East Coast markets of the United States, with an initial focus on the Boston, New York and Washington, D.C. markets. In preparation for the first Urban Air Mobility (UAM) flights with Eve’s aircraft, the companies have agreed to establish a working group that will study the requirements of future AOCs (Airline Operating Certificates) where Eve’s aircraft can be deployed in specific markets and missions. This same working group will also examine the feasibility of additional services from other types of urban air vehicles, which could further expand access into new markets.

HAECO accomplishes first Boeing 777 cabin reconfiguration for Aeroflot

HAECO Hong Kong, a member of the HAECO Group, announced today that it has recently accomplished cabin reconfiguration work on the first of Aeroflot-Russian Airlines’ (Aeroflot) Boeing 777-300ER aircraft. The new cabin interior is configured to increase the aircraft’s capacity from 402 to 427 seats, including 28 business-class seats, 24 comfort-class seats and 375 economy-class seats. The seat pitch averages 80cm in economy class and 96cm in comfort class. As for business class, passengers can enjoy an individual suite with a sliding door and an extra armrest, providing a high level of privacy. Each private suite is also fitted with an 18.5-inch HD monitor and a two-metre full-flat bed. HAECO Hong Kong accomplished this Supplemental Type Certificate (STC) input with Boeing as a design integrator and

the aircraft is fitted with the latest generation of Panasonic eX3 in-flight entertainment system. Passengers will enjoy the new cabin interior on all Aeroflot’s popular international and domestic routes. Two additional aircraft from Aeroflot’s B777-300ER fleet are scheduled to be equipped with this new interior in Q4 2021.

The Boeing 787 was delivered green to Jet Aviation’s Completions Center in Basel in October 2019 and was recently redelivered to the customer on schedule. The cabin interior was designed by an external design studio and included a number of complex features, all engineered and produced in-house at Jet Aviation. “The exceptionally low cabin noise Jet Aviation achieved on this aircraft is the culmination of long-term collaborative research and development between us, universities, OEMs and partner companies,” said Enrique Garrido Bosch, completions programme director for the programme. “We’re delighted to see our work lead the industry in sound space, and our customer was particularly delighted with his environment of calm. We are very excited about the possibilities for further innovation to develop and shape sound experiences.”

Continued interest in aircraft maintenance at Prague Airport has been confirmed as Czech Airlines Technics (CSAT) signed a new contract with another major customer. CSAT management has entered into a base maintenance agreement with Austrian Airlines. Based on a tender won by CSAT, the company will perform overhauls of a total of 13 Airbus A320-family aircraft. Despite several operational changes by air carriers, lessors and other aircraft operators in connection with the resumption of operations post the pandemic, over 100 projects were successfully completed last season. Based on the latest agreement concluded with Austrian Airlines, CSAT will provide Airbus A320-family narrow-body aircraft base maintenance using one of its production lines in Hangar F. Its team will perform a total of six overhauls this season. During the following year, seven more aircraft will arrive in Prague for the planned checks.

GA Telesis MRO Services Group reports record financial performance

GA Telesis' MRO Services Group has achieved a new record year in its financial metrics. As the 2021 fiscal year ends, the company reported sales and earnings above 2019 pre-pandemic levels. Spanish Ministries of Defence and Interior sign for 36 H135s

The Spanish Ministries of Defence and Interior have ordered 36 Airbus H135 helicopters. The Ministry of Defence will receive 18 helicopters to be operated by the air force and the navy while the Ministry of Interior will also take delivery of 18 helicopters to be operated by the National Police and the Guardia Civil. Deliveries will start next year. The Spanish Army already operates a fleet of 16 H135 helicopters. With this acquisition, these will be the Spanish Air Force's first H135s and the Spanish Navy's first Airbus Helicopters product. As was the case for the H135s acquired some time ago by the army, the new aircraft for the air force and navy will replace older helicopter models currently used for advanced pilot training. The standardisation of training fleets across the three armed forces will create synergies and lead to the implementation of new and more efficient training and support activities.

France orders Airbus H160M helicopter for Joint Light Helicopter programme

The French Armament General Directorate (DGA) has signed a contract with Airbus Helicopters for the development and procurement of the H160M in the frame of the Light Joint Helicopter programme (HIL). The contract includes the development of several prototypes and the delivery of a first batch of 30 aircraft (21 for the army, eight for the navy and one for the air force). The French Ministry for the Armed Forces plans to order a total of 169 H160M helicopters, or Guépard as it will be known in the French armed forces. Deliveries will start in 2027 beginning with the French Army. The first of a new generation of helicopters, the H160M is derived from the EASA-certified H160. It benefits from a low cost of operations and optimised flight safety. The H160 was designed to be a modular helicopter, enabling its military version, with a single platform, to perform missions ranging from commando infiltration to air intercept, fire support, and anti-ship warfare in order to meet the needs of the army, the navy and the air force. To ensure a high level of availability while reducing operating costs, the H160M's support and services needs were taken into account from early in its design phase. Innovative and simplified, the H160M's support is based on the exploitation of data through analytics.

Rolls-Royce to develop joint future fighter engine demonstrator with IHI

Rolls-Royce has agreed to work with Japan’s IHI Corporation to develop and deliver a future fighter engine demonstrator. The engine demonstrator programme will be a critical step forward in enabling the UK and Japan to develop their future fighter aircraft requirements, potentially securing hundreds of future jobs in the two countries. Work on the joint engine demonstrator will kickstart early 2022, with the UK investing an initial £30 million in planning, digital designs and innovative manufacturing developments. A further £200 million of UK funding is expected to go towards developing a full-scale demonstrator power system, supporting hundreds of highly skilled jobs, including many at Rolls-Royce’s Filton facility in Bristol. Rolls-Royce has a long and strong heritage of partnering in Japan through the development of technology, engineering and supply chain relationships since the 1960s. The company employs over 40 members of staff in the Kobe and Tokyo offices, and a further 5,000 Japanese work on Rolls-Royce programmes in its partner organisations. The recent technology programmes conducted by Japanese government and Japanese industries, coupled with access to the technologies being developed in the UK Tempest programme, will enable the development of a world-class next-generation power and propulsion system.
